“This joint venture marks a significant milestone in our journey into the waterproofing and construction chemicals market,” said Goh Chye Hin, Managing Director of SAC. “By leveraging SAC’s strong local expertise and CKS’s global innovation capabilities, we are confident in delivering high-performance waterproofing solutions tailored to Malaysia’s evolving construction landscape.”
